ARTICLE 1 Basis, Purpose and Scope

This directive has been prepared to define how to make presentations made by the members of the “Psychological Counseling and Guidance Education Programs Evaluation and Accreditation Unit (PDR-EPDAB)”, the members of the Accreditation High Council or the PCDR-EPDAB office on behalf of PDR-EPDAB, introducing PDR-EPDAB, explaining the accreditation process, standards or criteria of PDR-EPDAB.

ARTICLE 2 Definitions

In this guideline:

- (a) PDR-EPDAB, Psychological Counseling and Guidance Education Programs Evaluation and Accreditation Unit,
- (b) Members of the PDR-EPDAB, Members of the PDR-EPDAB,
- (c) AÜK, the Supreme Council for Accreditation,
- (d) the PCDR-EPDAB Office, the Secretary General of the PDR-EPDAB or the PDR-EPDAB staff designated by him/her, defines.

ARTICLE 3 PDR-EPDAB Introduction and Presentations

Prior to all PDR-EPDAB introductions and PDR-EPDAB presentations to be made by PDR-EPDAB AUK Members, PDR-EPDAB members or the PDR-EPDAB Office, the AUK must be informed. This can be done through the PDR-EPDAB Office or the Chair of the AÜK. Promotions and presentations on behalf of the Counseling and Psychological Counseling Service should use the most up-to-date information about the Counseling and Psychological Counseling Service and the standard formats of the Counseling and Psychological Counseling Service. PDR-EPDAB standard formats are available from the PDR-EPDAB Office. The electronic files of the presentations made on behalf of PDR-EPDAB within the knowledge of AÜK and the versions used in the presentation must be submitted to the PDR-EPDAB Office after the presentation.

ARTICLE 4 Amendments to the Directive

Proposals for amendments to this directive can be made by AÜK members, PDR-EPDAB members or the PDR-EPDAB Office. The amendment proposals are put on the agenda and decided at the first meeting of the AUC.

ARTICLE 5 Enforcement

This directive enters into force as of the date of its approval by the AUC.
